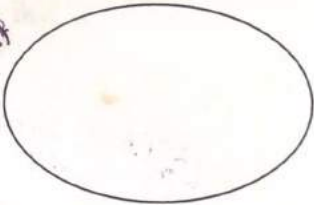

Whereas, the Settler is desirous of creating a Settlement or Trust by setting apart and establishing a Fund/sum of Rs. 5,000 . 00(Rupees Five thousand only, in words) for the Educational and Charitable objects and purposes in Orissa hereinafter expressed in the interest and for the benefit of the deserving meritorious students and deserving persons among the public.

And

Whereas, all the trustees jointly have agreed on the request of the Settler to act as the Trustees of these presents and to hold the said sum of Rs. 5,000. 00 and investments for the time being representing, to same and all other sum of properly that may from time to time form part of the trust fund upon the trusts hereinafter and declared and convening the same.

Now this deed witnesseth as under :

- A. In order to effectuate the said object/purpose of creating and establishing a Educational and Charitable Trust, the Settler has hereby transferred, assigned and made over to the trustees the said sum of Rs. 5,000 . 00 (Rupee Five thousand only, in words), with intent to part with all his right, title and interest claim therein and vest the same in the TRUSTEES to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represent the Trust Estate together with all additions and accretions there to and all accumulated income there of and all other property or properties that may be acquired out of the same or otherwise may hereafter be
